The mission of The Children's Place Association is to improve the present and secure the future for children, youth and families confronted by HIV/AIDS or other health problems.



## Message from the President

Dear Friends:

On August 1, 2006 The Children's Place Association marked our 15th anniversary of caring for children and families affected by HIV/AIDS and other serious medical issues. With your loyal commitment, we have touched the lives of more than 1,300 children.

In the past decade and a half, there has been progress in the fight against AIDS. Public health initiatives have dramatically reduced the number of children being born HIV positive. But AIDS remains a threat. Women of child-bearing years, especially in poor minority communities, represent a rapidly growing share of new HIV infections. In the past fifteen years, we have seen escalating numbers of children being born into HIV/AIDS-affected families. We have seen parental illness and poverty put these children at risk for malnutrition, developmental delays, social isolation, homelessness and neglect.

Our continuum of core services – residential care with 24-hour nursing; specialized early learning/day care for infants, toddlers and preschoolers; family support services such as case management, psychotherapy, in-home respite care and summer camp; foster care/adoption; and three units of supportive housing – provide life-saving and life-enhancing services that help build a brighter future for children and families impacted by HIV/AIDS.

We continue to develop new and innovative programs to meet new challenges in the AIDS epidemic. Our prevention program is reaching out to HIV positive pregnant women to help ensure good health outcomes for babies and lay the foundation for children's future academic achievement. Our Lifelong Families program, now in its second year, is stabilizing HIV/AIDS-affected families and helping ill parents plan for their children's future. Our support groups are helping HIV positive adolescents and teens navigate the complexity of growing up while facing the reality of their disease.

None of these important programs would be possible without our many valued friends, donors and volunteers. As we look back on the past fifteen years, and as we look ahead to the future, we are deeply grateful for your support. You are the source of our strength and success. On behalf of all us at The Children's Place – especially the children – thank you.

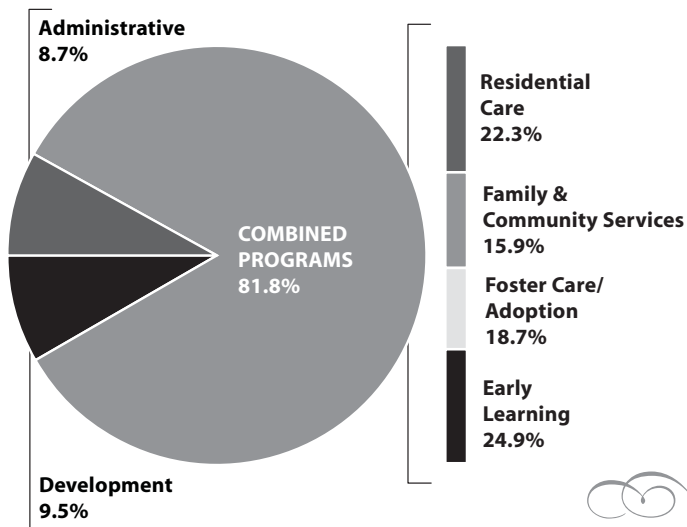

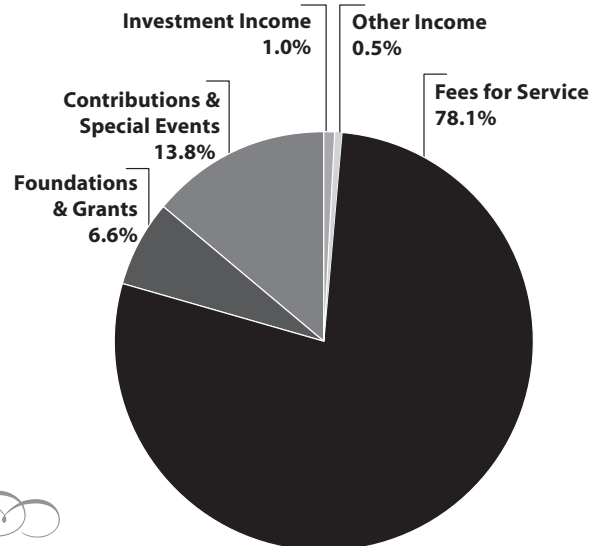

## 2006 Program Highlights

The Children's Place Association launched a new prevention program for pregnant and parenting HIV+ women. Funded by a grant from the Chicago Public Schools, and in close collaboration with the Erikson Institute and Pediatric AIDS Chicago – Prevention Initiative, the program helps women deliver healthy babies and give their children a better start in life. Services include weekly home visits by a clinical social worker and nurse and weekly therapeutic support groups.

In partnership with The Ounce of Prevention Fund, The Children's Place Association initiated a new Head Start Program within Early Learning/Day Care Program. Head Start augments The Children's Place Association's already substantive early childhood education services with the addition of a master teacher, a clinical social worker, additional classroom staff, and expert consultation and training.

The Children's Place Association established a formal partnership with the Erikson Institute, a nationally recognized research and education center on early childhood development. Through expert clinical consultation, training, graduate internships and program evaluation, the partnership will elevate the high standard of services The Children's Place Association provides to infants, toddlers and preschoolers.

Children's Place broadened the continuum of support services for HIV/AIDS-affected children and families to meet emerging challenges in the AIDS epidemic, in particu-

lar the challenges faced by HIV-positive children moving into adolescence. Ninety-two children and parents participated in therapeutic support groups for HIV+ adolescents and their families for a total of 1122 hours of group services. In addition, new educational advocacy and tutoring services were provided to eleven HIV/AIDS-affected families to help the children do well in school.

The Children's Place Association's core services continue to provide crucial care to children impacted by HIV/AIDS and other complex medical issues:

- 325 children and parents were provided with Family & Community Services, including case management, psychotherapy, in-home respite care, summer camp, recreational activities and other support services.
- 61 children were cared for through the Foster Care program, including 29 children with serious medical conditions. Eight children secured a permanent living arrangement through adoption or legal guardianship.
- 69 medically complex or HIV/AIDS-affected children were provided with 2334 days of Residential Care and 24-hour nursing.
- The Early Learning/Day Care Program provided 8063 days of full-day early childhood education services for 83 children ages three months – five years. Thirteen children completed the program and transitioned to kindergarten fully ready to learn.
